

Goodwood Roller Marathon Sponsorship

1. Print off the sponsorship form.

2. Get sponsored!

Remember to ask your sponsors to tick the Gift Aid box if possible. This means the NSPCC will get an extra 28p for every £1 donated at no extra cost to you or your sponsor. The NSPCC will only be able to claim Gift Aid on your sponsor's donation if they include a full name and address.

3. Complete the Goodwood Roller Marathon (or do as much as you can!)
